4. The maximum age limit for appointment by deputation shall not exceed 56 years with a residual service of four years as on the closing date of receipt of applications.

The application in the prescribed Pro forma (*Annexure-I*) of the eligible officer, who can be spared in the event of his/her selection may be forwarded to the Principal Registrar, Armed Forces Tribunal, Principal Bench, West Block-VIII, Sector-I, R.K. During the period of deputation, if the deputationist expresses a willingness to be 10. absorbed against the deputation post, such an application shall be considered in accordance with the provisions pertaining to absorption as set forth in the existing Recruitment Rules (RRs) and the applicable policy on the subject for the respective post.
