Any attempt to canvas will be considered as a disqualification.

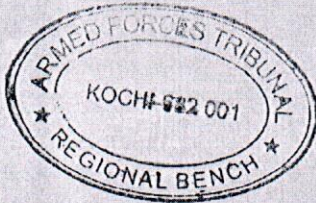

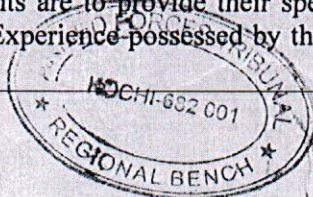

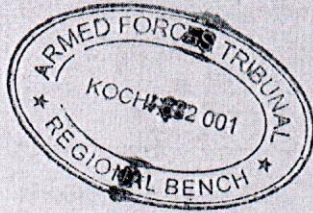
