CIRCULAR

Applications in the prescribed format are invited from the Indian Citizens, who fulfill the following qualifications, experience and other eligibility conditions for being engaged as Consultant (IT) purely on contract for a period of one year at a monthly consolidated remuneration of Rs 70,000/- in the Armed Forces Tribunal, Principal Bench, New Delhi:

Qualifications	Experience
Master of Computer Application/ Bachelor of Engineering/ Technology from recognized University or equivalent.	Minimum five years' experience in the working in client-server and web-based technologies, LAN/WAN Network Administration. OR Minimum five years' experience in IT/Software Development/IT System Projects/Website Management/Mobile Application in Website/Mobile Application Development for IT Projects/Database Administration.

2. **Age Limit:** Candidate must be of age between 45 and 60 years as on the last date of receipt of applications.
3. Before applying for Consultant (IT), the candidates should ensure that they satisfy the prescribed eligibility conditions therefor.
4. The application in the prescribed format of the eligible candidate must reach the Principal Registrar, Armed Forces Tribunal, Principal Bench, West Block-VIII, R.K. Puram, New Delhi 110066 latest by **22nd March, 2024** along with photo copies of the documents in support of his/her qualifications and experience, as prescribed above.
5. The applications received without supporting documents, unsigned and incomplete, in any manner, will be summarily rejected.
6. If, at any stage, it is found that the candidate does not fulfill any of the eligibility conditions or information furnished by him/her is found false or he/she has suppressed any material information, his/her candidature for Consultant (IT) will stand cancelled without any notice or further reference.

7. The Registry of the Tribunal reserves the right to enlarge or modify the scope of duties to be performed by the selected candidate for being engaged as Consultant (IT).
8. The engagement of Consultant (IT) will be purely contractual in nature for a period of one year, which can be extended, if the Tribunal so requires and the work and conduct of the candidate is found to be satisfactory. However, the Tribunal reserves the right to terminate the engagement as Consultant (IT) before the expiry of the term of engagement without assigning any reasons, whatsoever.
9. The engagement of the candidate selected for Consultant (IT) does not confer any right on him/her to claim regularization or continuance of his term of contract beyond one year.
10. Candidates who have already applied pursuant to the earlier notice dated 08th January, 2024 need not apply afresh.
11. No TA/DA will be payable to the candidates to appear for the interview.

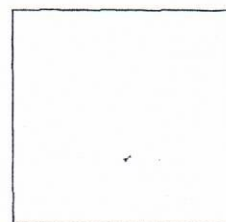
